Cost of Bid Document (Non-Refundable) must be in the form of Demand Draft/ Banker Cheque of a Nationalized Bank drawn in favour of the Principal Secretary, BTC, Kokrajhar and payable at SBI, Kokrajhar for amount as mentioned above.

Bids must be accompanied by Bid Security of an amount specified for the work as EMD in the above table in the form of Bank Guarantee or Fixed Deposit Receipt from any nationalized bank pledged in favour of the *Executive Engineer, PWD, Udalguri Rural Road Division, Udalguri*. The Bid Security should be valid for a period of 45 days beyond the validity of the bid i.e. 180 days.
