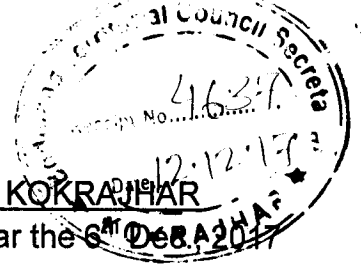



The original copies of the Cost of Bid Document, EMD along with one hard copy of Technical Bids with all supporting documents for the purpose of physical verification must be submitted manually as specified in the bid documents on or before bid submission closing date & time.

Cost of Bid Document (Non-Refundable) must be in the form of Demand Draft/ Banker Cheque of a Nationalized Bank drawn in favour of the Principal Secretary, BTC, Kokrajhar and payable at SBI, Kokrajhar for amount as mentioned above.


