Scanned copies of original hard copies of financial instruments towards cost of Bid Document and earnest Money Deposit must be submitted online. The original copies of the Cost of Bid Document, EMD along with one hard copy of Technical Bids with all supporting documents for the purpose of physical verification must be submitted manually as specified in the bid documents on or before bid submission closing date & time.

Cost of Bid Document (Non-Refundable) must be in the form of Demand Draft/ Banker Cheque of a Nationalized Bank drawn in favour of the Principal Secretary, BTC, Kokrajhar and payable at SBI, Kokrajhar for amount as mentioned above.

Bids must be accompanied by Bid Security of an amount specified for the work as EMD in the above table in the form of Bank Guarantee of Fixed Deposit Receipt from any nationalized bank pledged in favour of the Kokrajhar. The Bid Security should be valid for a period of 45 days beyond the validity of the bid i.e. 180 days.

Bidders may open User ID and Password by registering online at the website <http://assamtenders.gov.in> for online submission of bids. Bidders who do not have Digital Certificates may acquire the same from the approved providers under NIC in order to enable to participate in the bidding process.
